1. ACKGROUND/RATIONALE

Anemia is a major public health problem across all age groups in Jharkhand. Government of India as launched Anemia Mukt Bharat programme to address anemia. It uses the 6X6X6 strategy and aims to reduce the prevalence of anemia among various groups, including children (6-59 months), children (5-9 years), adolescents (10-19 years), pregnant women, lactating women, and women in reproductive age (15-49 years). UN ORGANISATION is working closely with Health Dept, Govt of Jharkhand to strengthen implementation of Anemia Mukt Bharat programme strategies including prophylactic iron and folic acid supplementation; deworming, testing and treatment of anemia and intensified year-round behaviour change communication campaign. This consultancy is being proposed to provide technical support to Health Dept strengthen the implementation of Anemia Mukt Bharat programme.
