#### **CONTENT OF TERMS OF REFERENCE FOR INDIVIDUAL CONSULTANT**

#### **1. BACKGROUND / RATIONALE**

UN ORGANISATION works with governments and partner to support the delivery of essential nutrition interventions. The support is aimed at ensuring that young children, adolescents, and pregnant women, especially the most vulnerable, have access to and utilize gender-responsive quality nutrition i interventions and adopt healthy diets and nutritional care practices. It works through the national flagship of National Health Mission, POSHAN 2.0 and National Rural Livelihood Mission.

India has a population of 10.45 crore Scheduled Tribes (STs), as per Census 2011, which constitutes 8.6% of the total population. Some of the tribal communities who live in remote forest areas, have low socio economic and health indicators and suffer from high vulnerability compared to other tribal communities, have been categorized as Particularly Vulnerable Tribal groups (PVTGs). For livelihood, a majority of PVTGs rely on forest resources and agricultural

activities. These 75 PVTGs reside in 18 states and the Union territory of Andaman and Nicobar Islands.

Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) has been recently launched to enhance the socio-economic conditions of Particularly Vulnerable Tribal Groups. This initiative aims to provide essential amenities such as secure housing, clean drinking water, sanitation, improved access to education, health, and nutrition, as well as enhanced road and telecom connectivity, and sustainable livelihood opportunities to PVTGs households and habitats. Since it's a new scheme, Ministry of Tribal Affairs is looking for technical support from a host of UN agencies

The current consultancy is targeted at supporting the Ministry of Tribal Affairs and Nutrition section in Delhi to deliver on select nutrition priorities focusing on improving nutrition programing

### 2. PURPOSE OF THIS ASSIGNMENT

Under the overall supervision of Nutrition Specialist within UN ORGANISATION and the Ministry of Tribal Affairs, the proposed consultancy has been designed to support the national teams in providing technical support, operationalizing and documenting select elements of implementation framework which will contribute to the delivery of results.

The consultant will provide relevant technical expertise, coordination, and documentation support, and work closely with the Nutrition section and also engage with Health and Social Behaviour Change (SBC) teams for effective coordination, planning and delivery of nutrition interventions in tribal areas and allied ministries. As part of consultancy the consultant will be required to provide specific support to in tracking progress, preparing monitoring, supportive supervision tools, consolidating and analyzing data driven by government requirement, finalizing case studies and need based documentation, contributing to the review process and developing quarterly report cards and progress reports. The position is for a period of one year.

## 3. PROGRAMME AREA AND SPECIFIC PROJECT AREA

- 3.1 By 2027, government and partners have increased capacity for equitable, evidence-based and risk informed policies and programmes, financing and leadership for implementation of policies and initiatives
- 3.2 By 2027, government and partners have capacities to increase equitable access of young children to nutritious foods and high nutrition impact services to prevent all forms of malnutrition and manage wasting
- 3.3 By 2027, government and partners have capacities to increase equitable and gender sensitive responsive access of adolescents and pregnant women to nutritious foods and high nutrition impact services to prevent all forms of malnutrition and treatment of nutrition risks
- 3.4 By 2027, families are aware, have greater knowledge about nutritious foods to adopt healthy diets lifestyle and optimal young child feeding and care practices

- Work closely with UN Organisation and the Tribal department to support and feed into tribal state and district action plan with focus on nutrition and SBCC elements
- Consolidate available training package on anemia management, prevention and management of wasting for tribal population

- Jointly with the National team support in facilitating briefing of state teams, reviewing state and district plans for capacity building and consolidating progress on the training component
- Prepare data driven (qualitative and quantitative) sheets, highlights which can be used for programme reviews
- Coordinate with SBCC section and Advocacy section to support tribal department in preparing a communication package for rollout in tribal pockets
- Jointly with team in the Ministry support in documenting human interest stories/case studies on intervention areas
- Review technical briefs, report cards, data sheet, prepared by states and provide analytical feedback
- Keep abreast with latest technical and programme briefs with regards to tribal health and nutrition as well as ongoing nutrition schemes in other departments which have a bearing on nutrition
- Prepare draft quarterly progress report, bottleneck analysis and technical updates
- Liaise with other team members in SPMU and allied ministries to identify the communication activities, events and actions needed for accelerating tribal nutrition plan
- Liaise closely with the tribal department to identify opportunities existing within PIPs for inclusion and integration of field learnings in government plans
