TERMS OF REFERENCE

1. BACKGROUND/RATIONALE

As per 5th round of National Family & Health Survey, 22% children under 5 years are wasted and 9.1 % children are severely wasted in Jharkhand. Acutely malnourished children are at greater risk of morbidity and mortality. Jharkhand had established 101 Malnutrition Treatment Centres for facility-based management of children with SAM. Government of Jharkhand has also launched the community-based management of acute malnutrition (CMAM) program, i.e., Strategic Action for alleviation of Acute Malnutrition and Anemia Reduction (SAAMAR) program across 24 districts.

State Centre of Excellence for Management of Severe Acute Malnutrition (SCoE-SAM) was established in October 2019 at Rajendra Institute of Medical Sciences, Ranchi, to provide technical support to government in strengthening management of children with SAM under CMAM and FSAM programs.
