### CONTENT OF TERMS OF REFERENCE FOR INDIVIDUAL CONSULTANT

# 1. BACKGROUND / RATIONALE

According to the Census of 2011, Bihar accounts for 10.7% of the child workers in India in the age group of 5 to 14 years. There are 4.5 lakh children in the 5- 14 years age group falling in the category of main workers and about 6.3 lakh children in the category of marginal workers; main workers are those who work for 6 months or more in a year, and marginal workers are those who work for less than 6 months in a year. Bihar has the third-largest number of child labour in the country. Some common causes of child labour are poverty, parental illiteracy, social apathy, ignorance, lack of education and exposure, exploitation of cheap and unorganized labour. The family practice to inculcate traditional skills in children also pulls little ones inexorably in the

trap of child labour, as they never get the opportunity to learn anything else. Absence of quality education at the primary level, parental ignorance regarding the bad effects of child labour, the ineffectively of child labour laws in terms of implementation and cheap child labour are some other factors which encourages the phenomenon of child labour.

Government of Bihar formulated State Action Plan for Elimination of Child Labour and Prohibition and Regulation of Adolescent Labour in 2017. It takes a holistic approach to achieve its vision of "child labour free Bihar" by preventing the incidents of child labour, empowering girls and boys and to provide socio-economic, legal, education and health services to those affected by it. Labour Resources Department is the nodal department for the implementation of the State Plan of Action. The department coordinates with all departments of the State Government, UN agencies, NGOs and other civil society organizations for effective convergence of various programs and schemes for the rehabilitation of the child and adolescent labour.

UN ORGANISATION has been providing technical assistance to Labour Resources Department (LRD) as well as Social Welfare and Education Department in the implementation of the State Action Plan. The emphasis is to support in using social protection measures, capacity development of key functionaries including the frontline functionaries. UN ORGANISATION assisted in the development of Child Labour Tracking System (CLTS) which has been integrated with the existing CP-MIS platform. CLTS provides a framework to facilitate case management of rescued child labours. It is a unique innovation as it bridges rescue with rehabilitation of child labours.

Despite a strong legal and policy framework, a large number of children are vulnerable to violence, abuse, and exploitation risks. An estimated 1 million children of Bihar in the age group of 5 to 14 years are engaged in work. COVID-19 has further exacerbated the risks of child labour and trafficking due to its economic impact on poor and vulnerable groups. There is evidence that children and adolescents affected by violence, abuse, and exploitation also have serious mental health issues. Hence it is extremely important to strengthen MHPSS services for them, specially curated to address their specific needs.

The online landscape has become a place where child sexual abuse material (CSAM) is being captured and shared, such as through peer-to-peer (P2P) and Darknet networks. Victims are being abused and exploited in the physical world, and then re-traumatized when these images and videos are shared in the virtual world. In some cases, these worlds converge through new technology such as live streaming. UN ORGANISATION will work with CyberPeace Foundation, Monash University, Australia, Bihar Police and IIT Patna to address the issues of cyber safety in Bihar.

#### 2. PURPOSE OF THIS ASSIGNMENT

To provide technical assistance to the Labour Resources Department, Social Welfare Department, Education Department and Home Department in the effective implementation of State Action Plan for Elimination of Child Labour and Prohibition and Regulation of Adolescent Labour in the state with specific focus on high prevalence districts. Provide handholding and capacity building on Mental Health and Psychosocial Support (MHPSS) and implementation of project on Cyber Safety.
