1. Background

Mental health is being recognized as one of the priority areas in health policies around the world and has also been included in the Sustainable Development Goals. In 2017, over 1 billion people worldwide were affected by mental and addictive disorders. These disorders accounted for 7% of the global disease burden (measured in DALYs) and 19% of all years lived with disability. (Source: Global Burden of Diseases, Institute for Health Metrics and Evaluation, 2017 Report).

The prevalence of mental illness is estimated to be about 10 per 1000 population. In 2017, 19.3 million people had mental disorders in India, including 45.7 million with depressive disorders and 44.9 million with anxiety disorders. The contribution of mental disorders to the total DALYs in India increased from 2.5% in 1990 to 4.7% in 2017. As per National Mental Health survey (NIMHANS Bengaluru), overall prevalence of mental illness in lifetime was 13.7% and current is 10.6%. Current prevalence of anxiety disorders and depressive disorders were 3.6%, and 0.8% respectively.

The Government of India has launched the National Mental Health Program (NMHP) in 1982, keeping in view the heavy burden of mental illness in the community, and the absolute inadequacy of mental health care infrastructure in the country to deal with it. The Program envisages a primary health care community-based approach in the rural areas

supported by professional psychiatric supervision from the district level and referral services by the mental hospitals and mental health units of the general hospitals.

2. Purpose of assignment

UN ORGANISATION will support state on NMHP with focus on adolescents, pregnant women, and children. The objective of the assignment is to provide technical support for capacities building, mentoring visits and demand generation along with demonstration of model for improving service delivery in mental health program.
